

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN GENERAL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2006**

**WHEREAS**, on February 1, 2006 a new Weakley County Clerk & Master was appointed to fill the vacancy of retiring Clerk & Master Patricia Taylor; a new six year surety bond and commissioners/receiver bond was necessary for the newly appointed Clerk & Master; and

**WHEREAS**, the Weakley County Sheriff's Department is a member of the Tennessee Public Safety Network whose purpose is to provide assistance to other law enforcement agencies when critical incidents arise, these local agencies receive reimbursement from the Federal Emergency Management Agency; and

**WHEREAS**, the Tennessee Public Safety Network dispatched members of the Weakley County Sheriff's Department to the States of Mississippi and Louisiana due to the striking of Hurricanes Rita and Katrina; and

**WHEREAS**, the Weakley County Sheriff has been successful in obtaining a State of Tennessee grant (75/25 split) for the purchase of an electronic fingerprint machine, the total cost of the machine and supplies is \$19,540; and

**WHEREAS**, during the 2004-05 fiscal year the Weakley County Emergency Management received a \$50,000 homeland security grant for the purchase of a emergency management vehicle and communication equipment for the vehicle that continues into the 2005-06 fiscal year.

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 27<sup>th</sup> of March 2006 in Dresden, Tennessee that:
