RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN DRUG CONTROL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2006

WHEREAS, the United States Office of Justice Programs' Bureau of Justice Assistance has awarded the Weakley County Sheriff Department a Bulletproof Vest Partnership (BVP) grant (50/50 split) for the purchase of bulletproof vests for county deputies; and

WHEREAS, bids have been solicited for the purchase of the bulletproof vests, funds are available in the drug control fund to provide Weakley County's 50% match, grant funds should be placed in the 05-06 FY budgeted.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 27th of March 2006 in Dresden, Tennessee that:
