**RESOLUTION NO. 2006-56**

**2006-2007FY TENTATIVE BUDGET FOR THE WEAKLEY COUNTY  
GENERAL FUND, WEAKLEY COUNTY HIGHWAY FUND,  
WEAKLEY COUNTY DEBT SERVICE FUND, WEAKLEY COUNTY  
DEPARTMENT OF EDUCATION FUND, AND SOLID WASTE FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 2006.**

**WHEREAS**, due to the State of Tennessee, Department of Education, and other state departments not providing current financial budget information to Weakley County in a timely manner; and

**WHEREAS**, county revenue from the state budget is vital to preparing the Weakley County Revenue and Expenditure Budget; and

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 26th day of June 2006 in Dresden, Tennessee that the adopted Weakley County 2005-2006 General Fund, Highway Fund, Debt Service Fund, Department of Education, and Solid Waste Fund budgets be adopted as the 2006-2007 FY Tentative Budget; and

**SECTION 1. BE IT FURTHER RESOLVED**, that no more than 15% of any item be expended per calendar month by each Department without the approval of the Weakley County Board of Commissioners Finance, Ways, and Means Committee until the final 2006-2007 FY Budget is adopted.

**SECTION 2. BE IT FURTHER RESOLVED**, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

**SECTION 3. BE IT FURTHER RESOLVED**, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
