**A RESOLUTION TO APPOINT A RULES COMMITTEE OF THE WEAKLEY COUNTY BOARD OF COMMISSIONERS**

**WHEREAS**, the County Board of Commissioners has such a committee in place, and the need may arise to amend said rules and with the need to appoint committees of the Weakley County Board of Commissioners; and

**WHEREAS**, there will be new County Commissioners elected in the August 3, 2006, General Election; and

**NOW THEREFORE, BE IT RESOLVED** by the Weakley County Legislative Body meeting in regular session on this 31st day of July, 2006, that:

**SECTION 1.** Nine (9) County Commissioners be appointed to serve on a committee to study the rules, procedures, and committee structure of the county legislative body, to make recommendations for committee assignments and to make nominations to fill offices as required by law to be filled by the County Commission.

**SECTION 2.** The committee members appointed shall be as follows:



**SECTION 3.** The first meeting of the committee will be at 8:30 a.m. in the County Courthouse on Friday, September 1, 2006.




