

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2007

WHEREAS, funds need to be appropriated to purchase office furniture for the newly-elected County Mayor, available funds were located in the county attorney legal services line item; and

WHEREAS, Weakley County possess a balance of \$24,543 in grant funds from the State Election Commission, there is a need for the purchase of additional election equipment; and

WHEREAS, the Weakley County Office on Aging-Dresden Center received additional revenue contributions for the chartering of a bus for a senior citizen's trip; these monies should be placed in the corresponding line items; and

WHEREAS, the Local Government Insurance Pool conducted a workman's compensation audit and additional worker's compensation premium is due in the amount of \$3,878.




