

RESOLUTION NO. 2007-29

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN HIGHWAY CAPITAL PROJECTS FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2007.
