

RESOLUTION TO APPROVE CHAPTER 135, TENNESSEE CODE ANNOTATED,
TITLE 5, CHAPTER 14, RELATIVE TO COUNTY GOVERNMENT PURCHASING.

WHEREAS, the Tennessee General Assembly has enacted an act to amend TCA, Title 5, Chapter 14 relative to county government purchasing and an act to amend TCA §54-7-113 relative to county uniform highway law; and

WHEREAS, Weakley County's purchasing policies should be amended to reflect the amendment of TCA, Title 5, Chapter 14 and TCA §54-7-113 relative to county government purchasing; and

WHEREAS, the bid limit is established by the Financial Management Committee under TCA §5-21-120, which provides that the amount set by the Committee is "not to exceed the amount as authorized by state law," the statute references the other purchasing laws, and these laws were amended to set the maximum amount at \$10,000, the amount in counties under the 1981 act is also raised to \$10,000 by reference. Therefore, the Financial Management Committee is now authorized to raise the bid limit to an amount not exceeding \$10,000.

NOW, THEREFORE, BE IT RESOLVED Weakley County's purchasing policy shall be amended by deleting the language "five thousand dollars (\$5,000)" wherever it appears and substituting the language "ten thousand dollars (\$10,000); thus the new bid limit for Weakley County government shall be \$10,000.

BE IT RESOLVED, that by the Weakley County Legislative Body meeting in Regular Session at Dresden, Tennessee, on this 28th day of June, 2007, that: Chapter 135, TCA, Title 5, Chapter 14 and TCA §54-7-113 relative to county government purchasing be approved.

BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

BE IT FURTHER RESOLVED, that this resolution shall take effect upon passage by a majority of the members of the Board of County Commissioners of Weakley County, Tennessee.
