**Resolution Authorizing Budget Amendments  
To The School Federal Projects Fund  
For The Fiscal Year Ending June 30, 2009.**

**WHEREAS**, the federal projects fund involves only federal monies and no local tax dollars, these funds are used in accordance with the provisions of No Child Left Behind for the betterment of the education of children in Weakley County, and the expenditure of these funds must be in compliance with federal law; and

**WHEREAS**, the Federal Projects Preschool Grant has been awarded additional Preschool bonus funds; and

**WHEREAS**, the budgets must now reflect the total federal allocations for each project and must include all previous carryover funds in the current project budget, and

**WHEREAS**, recent changes in the interpretation of the regulations of No Child Left Behind, regarding the use of Consolidated Administration, require that at least some monies from each of the projects consolidated must be included

**NOW, THEREFORE, BE IT RESOLVED** By the Board of Commissioners of Weakley County, Tennessee, assembled in regular session on this the 17th day of November, 2008 that:
