

RESOLUTION AUTHORIZING BUDGET AMENDMENTS AND WEAKLEY COUNTY, TENNESSEE HIGHWAY FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2009

WHEREAS, a budget amendment is necessary to transfer funds from within the budget to the building maintenance and repair line for the purpose of implementing a secondary source of power in the event of a power outage at the Highway Dept and Service Station; and

WHEREAS, extra funds are available in the other road materials line which is used for striping. These funds are available due to the fact that no roads will be ready for striping until next budget year.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 23rd day of March, 2009 in Dresden, Tennessee that this resolution is hereby approved.
