

RESOLUTION NO. 1993-06  
 RESOLUTION AUTHORIZING BUDGET AMENDMENT  
 TO THE GENERAL FUND  
 FOR THE FISCAL YEAR ENDING JUNE 30, 1993

WHEREAS, the Weakley County Sheriff's Department has applied for certain grant monies through the State of Tennessee, Governor's Highway Safety Program for the purpose of establishing and operating a DUI Task Force for Weakley County, and,

WHEREAS, funding for this program has been approved for the 9 month period ending September 30, 1993, and,

WHEREAS, these events having occurred require adjustments in the Fiscal Year 1992-1993 Weakley County General Fund Budget.


SECTION 1. The General Fund is hereby amended as follows:




